**NOTICE OF LIQUIDATION OF INSURER &  
DEADLINE TO FILE PROOF OF CLAIM**

TO ALL CLAIMANTS HAVING CLAIMS AGAINST THE RECEIVERSHIP ESTATE OF LUMBERMEN’S UNDERWRITING ALLIANCE.

PLEASE REVIEW THIS NOTICE CAREFULLY, AS IT SETS OUT IMPORTANT INFORMATION CONCERNING YOUR RIGHTS AND RESPONSIBILITIES AS A POTENTIAL CLAIMANT.

Please take note that on May 23, 2016, the Circuit Court of Cole County, Missouri, Judge Joyce presiding, ordered that Lumbermen’s Underwriting Alliance (“LUA”) be liquidated and that all remaining distributable assets of LUA be distributed to approved claimants of record.

The records of LUA indicate that you may have a claim against LUA. You may print a Proof of Claim at [www.lumbermensunderwriting.com](http://www.lumbermensunderwriting.com). Alternatively, you may request a Proof of Claim by contacting the Special Deputy Receiver at the phone number and address below. **Please read the instructions carefully and complete a Proof of Claim if you believe you have a claim. Failure to fully complete the Proof of Claim and to submit supporting documents, narratives, exhibits or evidence could result in your claim being denied.**

THE DEADLINE FOR SUBMITTING YOUR PROOF OF CLAIM IS **May 24, 2017**. If you wish to have an opportunity to share in the distribution of the available liquidated assets, **your Proof of Claim must be postmarked by May 24, 2017**. Proofs of Claim postmarked after **May 24, 2017** will be considered “late-filed.” Late-filed claims will in all likelihood receive no distribution, given the insolvent financial position of LUA.
